This momentum is expected to continue with MIS remaining ClearStar’s primary growth driver by service offering.

Robert Vale, CEO of ClearStar, said: “The expansion of our medical screening business has been fundamental to ClearStar’s growth and continues to be our key driver by service offering. Todd has been instrumental to this success and we’re delighted to promote him to President of Medical Information Services. His skills and expertise, supported by his talented team, have contributed to the solid execution of our strategies to grow our MIS sales. As we continue to invest in advancing our technologically-differentiated solutions, and broaden our reach into new markets, we look forward to reporting further progress.”

In his role as President, Todd will continue to provide direction and leadership of the MIS business and daily operations of ClearStar’s Medical Review Office, which implements independent and expert scrutiny of laboratory results under medical confidentiality. He is also responsible for ensuring that drug testing is conducted in compliance with state, federal and local regulations.
